The Family Alumni Bursary applies to students who previously had or currently have a parent, brother or sister studying at the University of Tasmania. Applicants whose parent or sibling relationships vary from the traditional core family unit, such as blended families, and whose relationship cannot be legally confirmed by a birth certificate, passport or evidence of adoption, may not be considered for the Family Alumni Bursary.

The bursary is only available to eligible Bachelor of Medicine and Bachelor of Surgery students who commence studies in 2021 or 2022.

This bursary will reduce the registered tuition fees for the intended academic study program by 10 per cent.

### If a student has already been offered a Tasmanian International Scholarship (TIS) or other 10% tuition fee discount this Family Alumni Bursary will not apply.

Applications for the Family Alumni Bursary must be submitted **prior to** the <u>Census Date</u> of the first semester of study to ensure the fee reduction will apply for that semester and onwards. The census date for Semester 1 falls on March 23. The census date for Semester 2 falls on August 10. All required documentation must be attached with this application when it is lodged with International Admissions (International.Admissions@utas.edu.au).

Failure to submit all required documents will delay the authorisation and processing of the Family Alumni Bursary.

Documentation required for BOTH present or past students includes certified copies of the originals (as shown below):

- Applicant's Birth Certificate (Original and English translation)
- Sibling's Birth Certificate (Original and English translation)
- Passport bio-data page for Applicant
- Passport bio-data page for Parent
